Evaluation Lesson

New clients are required to take an evaluation lesson so the Instructor can gauge their level of experience. This also affords the client an opportunity to evaluate if CatchRide Academy is for you.

1 hour Evaluation lesson – \$100 per rider

Payment is due prior to the lesson. Please complete the Credit Card Authorization Form to have lessons charged automatically to your credit card. Payment can be made at the barn office.

Prepaid Lessons

We offer a discounted lesson rate to clients that wish to pay for their calendar month lessons in advance. Payment is due on the 1st of the month for this **fixed rate**. **A la carte** lessons must be paid prior to lesson.

- a. Private Lessons (1-2 people).
 - i. \$100 – a la carte.
 - ii. \$430 – Monthly rate for a weekly private lesson (payment due at 1st of month).
- b. Group lessons (3-5 people) – all are Monthly Fixed Rates (payment due at 1st of month).
 - i. \$340 – Monthly rate for 1 lesson per week.
 - ii. \$675 – Monthly rate for 2 lessons per week.
 - iii. \$880 – Monthly rate for 3 lessons per week.

24 Hour notice of cancellation is required. Lessons cancelled within 24 hours will still be charged to the student - no exceptions

Students who forget about a lesson, don't show up or call to cancel, or don't want to ride, will still be charged for the lesson and will not be rescheduled.

If lessons are cancelled at least 24 hours in advance, you may schedule a make-up lesson within that same calendar month. Rescheduling lessons on short notice is based on availability and cannot be guaranteed.

Lessons that cannot be rescheduled will not be refunded.

Because we have back to back scheduled lessons, you must arrive on time for your lesson. Arriving late does not extend your allotted time slot; you will receive a shortened lesson. If a student is more than 15 minutes late to a lesson, the lesson may be cancelled. Arrive at least 10 minutes prior to your lesson.

HELMETS & APPAREL

Long pants and closed toe shoes/boots with a low heel are required. Helmets are required to be worn by ALL riders. We will provide a helmet if you do not have one of your own. All helmets must be ASTM/SEI approved.

SEVERE WEATHER

We teach rain or shine, day or early evening. In cases of severe weather, the student will be notified of lesson cancellations. Please note: extreme temperatures, lightning, and high winds constitute severe weather. If you are unsure about the weather, please contact your instructor or call 214-725-7664.

SAFETY

Safety is of the utmost importance to all of us. Please observe all warning and cautionary signage. Adhere to the barn rules; they are there for a reason. Supervision of children at Park Lane Academy is the responsibility of the parent. The instructor will supervise your child only during a scheduled lesson. If a student is "dropped off" for their lesson, please pick them up promptly when the lesson ends. Siblings should be supervised at all times. No running, rough play or screaming around the stable, as this may disrupt the riding lesson and the horses.

The Academy Program is designed to help students progress in logical steps and to offer information about horses, riding and care. While the majority of lesson time will be spent riding the horse, expect some time dedicated to safety, grooming, horse handling, equipment handling and care, ride preparation, after care and health.
